IA4 Bridge over UPRR

Mr. Palmer:

This letter is a follow up of our conversations regarding the 8" water Main owned by the City.

The contract plans call for installing 2,337.0 LF of trenched 8" PVC @ \$35.50 / LF; 110 LF of trenched and cased 8" PVC @ \$125.00 / LF; 180 LF of trenchless cased 8" PVC @ \$235.00 / LF; 3 - 8" Ductile Iron TEE's @ \$535.00 EA; 10-8" Ductile Iron 45 Degree MJ Bend @ \$450.00 EA; $12-\frac{3}{4}$ " Polyethylene Service Stubs @ \$1,900.00 EA; 1-1" Copper Service Stub @ \$2,600.00 EA; 5-8" Ductile Iron Pipe (DIP) Gate Valves @ \$1,475.00 EA; and 5-80 WM-201 Fire Hydrant Assemblies @ \$4,800.00 EA. The current contract price for these items is \$197,093.50.

During the Pre-Construction Conference the issue of potential soil contamination from current or previous Leaking Underground Storage Tanks (LUST) was brought up. Inquires to Iowa DOT's Office of Location and Environment (OLE) resulted in the identification of areas of concern. I include the report from OLE as Addendum A.

In reviewing the environmental report and discussions with Snyder & Associates and the Contractor the City indicated an interest in installing approximately 285 LF of 8" Ductile Iron Pipe with nitrile gaskets from about 50' south of Mckinley Street (Station 19 + 50) to a point just south of the bore/casing under the UPRR (Station 22 + 35). The purpose of this installation is to avoid installing a PVC pipe in potentially contaminated soil. The Contractor indicated a cost for the 8" DIP w/nitrile gaskets is \$67.10/LF. Deducting the \$35.50/LF cost of the 8" PVC, the additional cost of installing 8" DIP w/nitrile gaskets is \$9,006.00.

During the Pre-Construction Conference the City indicated an interest in installing two (2) additional 8" Ductile Iron Pipe Gate Valves to better accommodate isolating areas of the Main.

The Contractor proposed to install these additional valves at the contract price of \$1,475.00 EA

for an additional \$2,950.00.

Also, at the Pre-Construction Conference the City indicated an interest in extending the 8" PVC

Main from Head Street north to Central Avenue to tap into the existing 16" Main. The purpose of

the extension is the abandonment of the remaining 8" sand cast Main. The Contractor has

indicated the cost to cap the existing 8" sand cast Main at the 16" Main, install a service line to

the Harold & Gayleen Ruth property and install a stainless steel tap at the 16" Main to be

\$15,400; plus the installation of approximately 280 LF of 8" PVC from Head Street (Station 33 +

80) to Central Avenue (Station 36 + 60) at the contract price of \$35.50 at an additional \$9,940.00.

Summary of Proposed Additional Costs:

Ductile Iron Pipe w/ nitrile gaskets = \$ 9,006.00

Additional 8" Ductile Iron Valves = \$ 2,950.00

Extend 8" PVC to Central Avenue = \$25,340.00

Total Estimated Additional Costs = \$37,296.00

Assessment of these costs will be processed during the finalization of the project. Billing will be

handled by Iowa DOT Office of Finance.

We submit the costs of the above proposed additional work to the Jefferson City Council for

review and consideration. Should the City Council desire to move forward with the additional

work we would appreciate official notification. Upon notification in the affirmative lowa DOT will

process the necessary and appropriate Contract Modification(s) addressing the additional

estimated costs of \$37,469.85.

Please, note that the excavation for the water Main(s) will be monitored for indications of

contaminated soil. If contamination is discovered it may be necessary to take appropriate

mitigation measures. We will work closely with the City of Jefferson administration and staff to

keep them apprised of progress and any issues that may arise.
