How does the proposal promote the City of Jefferson? Thomas Jefferson Gardens Education and Welcome Center sponsored a Sunday afternoon concert August 4th, 2019, featured two Jefferson graduates; Ashley Sievers and her sister Shelby Sievers VanNorStrand who are both professional opera singers and performed several opera and non opera musical renditions along with their accompanist, Jolie Goble, for over an hour. A total of 180 people attended this music concert.

The concert was an attempt to highlight local artists. The one hour concert brought local residents and attracted other area people to downtown Jefferson. Although most of the stores were not open this Sunday afternoon, people attending spent a wonderful afternoon in downtown Jefferson. They heard the bells, they saw the sculptures, they could go up in the tower, they had a beautiful visual setting in the gardens, and they could feel that Jefferson was offering them many different experiences, the most outstanding being professional opera singers from their own community displaying their talents and talking about their experiences growing up here.

The Thomas Jefferson Gardens Education and Welcome Center is one of the top ten tourism attractions in Jefferson. The Gardens had an estimated 2,000 visitors last year. The Welcome Center serves as the first point of contact for Greene County tourists and is dedicated to provide a meaningful and helpful welcome to the historical and educational information about Greene County, Jefferson and the Thomas Jefferson Gardens. The Motel/Hotel tax is targeted to promote and encourage tourism and convention business in Jefferson. How does the proposal promote the City of Jefferson? Thomas Jefferson Gardens Education and Welcome Center has developed and implemented a Self-Guided Tour brochure for the Thomas Jefferson Gardens. The tour contains seventeen informational and education stops around the garden. This information was transformed into a three-fold brochure that visitors can use when exploring the gardens.

The Thomas Jefferson Gardens Education and Welcome Center is one of the top ten tourism attractions in Jefferson. The Gardens had an estimated 2,000 visitors last year. The Thomas Jefferson Gardens is the focal point of visitors to Jefferson and Greene County. Approximately 10 tour buses initiated their tours of Jefferson and Greene County at the Welcome Center. The Welcome Center serves as the first point of contact for Greene County tourists and is dedicated to provide a meaningful and helpful welcome to the historical and educational information about Greene County, Jefferson and the Thomas Jefferson Gardens. The Motel/Hotel tax is targeted to promote and encourage tourism and convention business in Jefferson. As a prominent tourism attraction in Jefferson, it is our belief Thomas Jefferson Gardens Education and Welcome Center will be an increasing tourist destination. This informational brochure about the gardens will only add to the positive experience that visitors have when visiting Jefferson and Greene County.

<u>Date of event or project start and end dates.</u> The TJG Self-guided brochure was developed during the spring of 2019. It was printed and delivered the first week of July.
