

ORDINANCE NO. 609  
AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY  
OF JEFFERSON, IOWA, 2017, BY AMENDING PROVISIONS  
PERTAINING TO VOTING PRECINCTS

Be it enacted by the City Council of Jefferson, Iowa:

SECTION 1. Section Amended. Section 3.02, Subsection 3 of the Code of Ordinances of the City of Jefferson, Iowa, 2017, is repealed and the following adopted in lieu thereof:

3.02(3). The City is divided into two election precincts, which shall be designated as “First Precinct” and “Second Precinct.”

- A. First Precinct. All that part or portion of the City lying and being within the limits of the following boundaries shall constitute and be the First Precinct of the City:

Commencing at the intersection of Elm Street and the north corporate boundary of the City of Jefferson; thence running south along the centerline of Elm Street to the south corporate boundary line of the City of Jefferson; thence east along the south corporate boundary line of the City of Jefferson to the southeast corner of the corporate boundaries of the City of Jefferson; thence north along the east corporate boundary line of the City of Jefferson to the northeast corner of the corporate boundaries of the City of Jefferson; thence west along the north corporate boundary line of the City of Jefferson to the point of beginning.

- B. Second Precinct. All that part or portion of the City lying and being within the limits of the following boundaries shall constitute and be the Second Precinct of the City:

Commencing at the intersection of Elm Street and the north corporate boundary of the City of Jefferson; thence running south along the centerline of Elm Street to the south corporate boundary of the City of Jefferson; thence west along the south corporate boundary line of the City of Jefferson to the southwest corner of the corporate boundaries of the City of Jefferson; thence north along the west corporate boundary line of the City of Jefferson to the northwest corner of the corporate boundaries of the City of Jefferson; thence east along the north corporate boundary line of the City of Jefferson to the point of beginning.

SECTION 2. Severability. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


SECTION 3. When effective. This ordinance shall be in effect after its final passage, approval, approval of the Iowa Secretary of State, delivery to the Greene County Auditor, and publication three times in the Jefferson Herald as provided by law.

Finally passed by the Council and approved on December 14, 2021.
