- Entry:** Fee: \$100.00
- Entries:** We would like a minimum of 8 teams in each grade level. If you are entering a mixed graded team, you must enter in the highest grade of your team members. We will be using 2 courts and will run our tournaments in a very efficient manner for teams and fans.
- Format:** All teams will likely play 3 games, unless the brackets are not full. The first game is tentatively set for 8:30am. Tournament schedules will be sent out on the Thursday prior to the tournament.
- Rules:** Iowa High School Rules, except for the following
- 1) Game consists of two – 14 minute halves with continuous clock. The clock will stop on dead balls the last minute of each half, on shooting fouls and for time outs.
 - 2) Half time is 3 minutes.
 - 3) One minute overtime. Second overtime will be sudden death.
 - 4) One time out per half. No carryover of time outs.
 - 5) No 3 point field goals.
 - 6) No pressing at any age level.
 - 7) You must play man to man defense.
- Roster:** No more than 15 players on your roster. Participating players, one scorekeeper and two coaches will be admitted for free. Teams should have similar light and dark shirts that are numbered.
- Lockerroom:** The GCCC will provide a locker room for participants to change in. Due to the use of the facility from our members, we ask that you take your belongings with you out of the locker room when you are done changing.
- Admission:** \$3 Adults \$2 Students
This is admission to the tournament only, not to use the facility.
