DESCRIPTION OF 2018-1 AMENDMENT:

The following projects would be added to the urban renewal plan:

- 1. Provide incentives to persons to make repairs and improvements to buildings in the downtown area, including repairs and improvements to roofs, exterior and interior walls, foundations, front facades, flooring, ceilings, and electrical, plumbing, and HVAC systems. The amount of tax increment revenues that may be used for this purpose shall not exceed \$150,000 for any one building and all of such projects shall not exceed \$600,000 in the aggregate for any one fiscal year.
- 2. Provide matching funds for façade rehabilitation projects in the downtown area, using tax increment revenues in an amount not to exceed \$300,000 in any one fiscal year.

For purposes of this Amendment the downtown area includes the portion of the Urban Renewal Area bounded on the west by Elm Street, on the north by Washington Street, on the east by the Raccoon River Valley Trail, and on the south by Harrison Street, and Block 32 in the Original Town (now City) of Jefferson.





Description of project. Jefferson Matters: Main Street and the Greene County Historical Museum are sponsoring the Smithsonian Institution's traveling exhibit entitled "HomeTown Teams" from August 11 – Sept. 23 in Jefferson at the Museum. This exhibit is a true Smithsonian exhibit with interactive displays that will be housed in the front space of the museum for at least 25 hours/week. This will be staffed by volunteers. A number of committees are in place for activities leading up to the date of the exhibit. Contacts to surrounding school districts have been made to draw in tours. We anticipate groups of people visiting the community to view the exhibit but also to enjoy the other attractions, restaurants, and various shopping. We have appreciated the financial help with the cost (\$1,500) of bringing this Smithsonian exhibit to Jefferson and \$400 that we have used to purchase a banner and magnets for promotion thus far. The banner has been hanging in the Masonic Lodge with the various sports displays since January 2018 and will be used during the Bell Tower Festival. We also plan to make a photo booth promoting the Smithsonian exhibit to be used at the Bell Tower Festival and RAGBRAI. The magnets have been handed out already but will also be given at the Festival.

Our next task is working on publicity with the HomeTown Teams committee making contacts with all of our local media – Raccoon Valley Radio, GreeneCountyNewsOnline, Jefferson Bee & Herald and the Scranton Journal for costs to publicize during the six weeks the exhibit is in town and the week prior to it. This would be a total of 7 weeks. We would also like to have our local Channel 9 display the hours that the exhibit is open. We have decided to spend \$275 in each of the 4 local media to publicize the dates and hours regularly and \$200 to display hours on Channel 9. We are requesting funds for this publicity.
