

Mike,

This project is proceeding smoothly despite all the delays and complications caused by the recent rainfall. The sanitary service for the Casino is still scheduled to be completed prior to the June 15th deadline that has been promised to the Wild Rose Casino. The project complexity and scope of work has changed since the approval of our original contract with the City of Jefferson dated July 8, 2014 for Utility Extensions on Mulberry Street and Wild Rose Casino. This contract was an estimate of that required to complete the following:

- 1. All the engineering services required to construct the water and sanitary service to the Wild Rose Casino. This was let in two projects, Phase 2 Water and Sanitary Hwy Crossings (J&K Construction) and Phase 3 Sanitary Extension and Lift Station (Scharnweber).
- 2. All the engineering services required to construct the Mulberry water and sanitary services to the Hunter project north of the Alliant Electric Maintenance Building.
- 3. Review the 12 inch interceptor for rehabilitation work between Grimmell Road and Grimmell Lift Station.

Those fees were estimated at \$153,500 for a 6 month construction period. The construction administration fees are very difficult to estimate due to all the variables involved to include the final scope of the project. Additions to the project scope subsequent to the contract approval include the following:

1. 12" Sanitary Interceptor Rehab.

All the work required to clean, televise and line with CIPP the 12" interceptor from Wall Street to the Grimmell Lift Station. That work includes preparation of plans, specifications, letting, construction administration, and observation. Also work was performed by Thorpe Lumber to clear the easement, which was facilitated through this office.

2. Gallup Road Utilities Extension

All that work required to construct sanitary and water to the GCDC property along Gallup Road, which was included as Division II to the Wild Rose Sanitary Extension and Lift Station project.

3. Grimmell Station Access and Site Improvements

All that work required to bid and construct this project. The project was let twice, however due to the fact that no bids were received (except Diane's) this project will be re-let this winter with anticipated construction in Spring, 2016.

4. Lift Station Modifications

Sincerely,

There were 4 lift stations to include the Redwood Station, the Restaurant (Highway 4) Station, the Wilson Avenue Station, and the Grimmell Station, all of which have an impact on the design of the Casino Lift Station. The parts and installation required to bring these stations back to design capacity was all facilitated through this office as part of this project.

We would request consideration of a contract amendment to our original contract for fees already rendered and upcoming for the additional projects that require construction period extensions. Those fees are estimated to increase our contract by \$43,000 to complete those projects currently under contract to construct. If approved we would request a signed "approved" copy of this letter returned for our records.
