NEW BUSINESS

- A. Public Hearing for Urban Renewal Amendment. The public hearing notice is attached
- B. **Resolution approving Urban Renewal Amendment.** The process to amend the Urban renewal area required a meeting with the County and School District to address concerns as well as a review by the Planning Commission to determine if the amendment was consistent with the Comprehensive Plan.
- C. **Appointment of volunteer fire fighters.** Robert Newby and Marcus Thomas are being recommended.
- D. Consider approval of pay estimate No. 4 (Sub Final) to King Const. for the 2014 Water Project. Payment amount is for \$32,034.95
- E. Consider approval of change order #1 (final) to King Const. for the 2014 Water **Project.** The net change order is \$2,819.20
- F. **Approval of easement acquisition with Greene County.** The easement would allow for the placement of a new water line at Wall Street between High Street and Walnut Street.
- G. **Approval of resolution authorizing internal borrowing**. This action would allow the City to borrow water reserve funds to pay for improvements until such time that the new tax property taxes from development become available in 2016.
