To fix a date of meeting for a public hearing on a proposed 2017 Amendment to the Jefferson Urban Revitalization Plan

WHEREAS, the City of Jefferson, Iowa (the "City"), pursuant to and in strict compliance with all laws applicable to the City, and in particular the provisions of Chapter 404 of the Code of Iowa ("Chapter 404"), has designated an area of the City as an urban revitalization area (the "Jefferson Urban Revitalization Area") and has adopted an urban revitalization plan for the Jefferson Urban Revitalization Area (the "Urban Revitalization Plan"); and

WHEREAS, pursuant to the provisions of Chapter 404, before amending the Urban Revitalization Plan, the City must publish a notice and hold a hearing; and

WHEREAS, a proposed 2017 Amendment to the Urban Revitalization Plan has been prepared and presented to the City Council for consideration, for the purpose of extending the eligibility period for property tax abatement benefits until the valuation date of January 1, 2020, and making the classification of multiresidential property eligible for benefits, which amendment is set forth as Exhibit A attached hereto; and

WHEREAS, it is necessary to set a date for a public hearing on the proposed 2017 Amendment to the Urban Revitalization Plan, pursuant to Chapter 404;

NOW THEREFORE, IT IS RESOLVED by the City Council of the City of Jefferson, Iowa, as follows:

- Section 1. This Council shall meet on the 12th day of December, 2017 at ______ o'clock p.m., at the Council Chambers, City Hall, at which time and place a public hearing will be held and proceedings will be instituted and action taken to approve the proposed 2017 Amendment to the Urban Revitalization Plan.
- Section 2. The City Clerk is hereby directed to give notice of the proposed action, the time when and place where said meeting will be held, by publication at least once not less than seven days and not more than twenty days before said meeting in a legal newspaper of general circulation in the City. Said notice shall be in substantially the following form:

NOTICE OF PUBLIC HEARING ON 2017 AMENDMENT TO CITY OF JEFFERSON URBAN REVITALIZATION PLAN

NOTICE IS HEREBY GIVEN: That there is now on file for public inspection in the office of the City Clerk of the City of Jefferson, Iowa, the 2017 Amendment to the Urban Revitalization Plan for the City, which proposes to extend the period of eligibility for property tax abatement benefits and to add the classification of multiresidential property to the types of property that are eligible for benefits under the Plan.

Under the 2017 Amendment, eligibility for property tax abatement benefits would be provided for all increased taxable valuations that go on the Greene County tax rolls by the valuation date of January 1, 2020. Residential, commercial, industrial and multiresidential properties will be eligible for a property tax abatement on new valuation for three years.

The City Council will meet at _____ o'clock p.m., on the 12th day of December, 2017, at the Council Chambers, City Hall, at which time a hearing will be held pursuant to the provisions of Chapter 404 of the Code of Iowa on the proposed amendment. At such public hearing all owners of record of real property, any tenants, all "occupants" of city addresses, and any other person having an interest in the matter may appear and be heard for or against the adoption of the proposed amendment.


