

ORDINANCE NO. 534
AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY
OF JEFFERSON, IOWA, 2008, BY AMENDING BOUNDARIES FOR
SECOND PRECINCT AND WARD

Be it enacted by the City Council of Jefferson, Iowa:

SECTION 1. Paragraph Modified. Paragraph B of Subsection 3 of Section 3.02 of The Code of Ordinances of the City of Jefferson, Iowa, 2008, is repealed and the following adopted in lieu thereof:

3.02 COUNCIL WARDS AND VOTING PRECINCTS.

B. Second Ward and Precinct. All that part or portion of the City lying and being within the limits of the following boundaries shall constitute and be the Second Ward and Precinct of the City:


Commencing at the intersection of the centerline of the Union Pacific Railroad Company right-of-way and the east corporate boundary line of the City of Jefferson; thence north along the east corporate boundary line of the City of Jefferson to the northeast corner of the corporate boundaries of the City of Jefferson; thence west along the north corporate boundary line of the City of Jefferson to the northwest corner of the corporate boundaries of the City of Jefferson; thence south along the west corporate boundary line of the City of Jefferson to the centerline of 237th Street; thence east along the centerline of 237th Street and Westwood Drive to the point of intersection with the centerline of the west end of Rushridge Road; thence south, east and north along the centerline of Rushridge Road (a horseshoe-shaped street) to the point where the centerline of the east end of Rushridge Road intersects with the centerline of Westwood Drive; thence east along the centerline of Westwood Drive to the centerline of Grimmell Road; thence south along the centerline of Grimmell Road to the centerline of West South Street; thence east along the centerline of West South Street to the centerline of High Street; thence north along the centerline of High Street to the centerline of Lincoln Way; thence east along the centerline of Lincoln Way to the centerline of Wilson Avenue; thence north along the centerline of Wilson Avenue to the centerline of the Union Pacific Railroad Company right-of-way; thence northeasterly along the centerline of said railroad right-of-way to the point of beginning.

One member of the Council shall live in and be nominated from the Second Ward.

SECTION 2. Severability. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


SECTION 3. When effective. This ordinance shall be in effect after its final passage, approval and publication as provided by law.


